## Code of conduct

### Compliance

#### 1. Adherence to Safety Regulations

- **Mandatory Briefings:** Ensure all team members attend all safety briefings conducted by the event organizers.
- **Safety Protocols:** Follow all established safety protocols, including those for vehicle handling, pit operations, and emergency situations.
- **Personal Protective Equipment (PPE):** Ensure that all team members wear appropriate PPE, including helmets, fire-resistant suits, and other required gear.

#### 2. Respect for Marshals and Event Staff

- **Cooperation:** Always cooperate with marshals and event staff, responding promptly to their directions and requests.
- **Reporting Issues:** Report any safety concerns or breaches of protocol to event staff immediately.

### Environmental Responsibility

#### 1. Minimizing Environmental Impact

- **Route Adherence:** Stick strictly to designated routes to prevent environmental damage.
- **Noise Control:** Minimize unnecessary noise, especially in environmentally sensitive areas. Drive at low revs outside the special stages to minimise carbon emissions.
- **Car sharing:** Choose car sharing if possible or walk for short distances

#### 2. Waste Management

- **Waste Disposal:** Dispose of all waste in the designated waste zones. Use the provided facilities to separate recyclables from other waste.
- **Car wash:** Car washes may only be carried out in the designated areas.

- **Environmental Spills:** Immediately report any oil, fuel, or chemical spills to event organizers and take action to contain and clean up the spill as directed. Always use mats when refuelling and in the service park.

## Behaviour and Sportsmanship

### 1. Professionalism

- **Conduct:** Always maintain a high standard of conduct, treating all participants, officials, and spectators with respect.
- **Sportsmanship:** Compete fairly and honourably, avoiding any actions that could be considered unsportsmanlike or detrimental to the integrity of the event.

### 2. Incident Reporting

- **Safety Hazards:** Report any observed safety hazards or unsafe behaviour to event officials immediately.
- **Accidents and Incidents:** In the event of an accident or incident, provide a detailed report to the event officials as soon as possible.

## Team Responsibilities

### 1. Vehicle Safety

- **Pre-Event Checks:** Perform thorough pre-event checks on all vehicles to ensure they meet the event's safety standards.
- **Maintenance:** Conduct regular maintenance throughout the event to prevent mechanical failures. Keep detailed records of maintenance activities.
- **Compliance:** Ensure all modifications to vehicles comply with the event's regulations.

### 2. Team Conduct

- **Discipline:** Maintain discipline within the team, ensuring all members follow the event's code of conduct and act responsibly.
- **Training:** Provide regular training to team members on safety procedures, environmental responsibility, and professional conduct.

### 3. Communication

- **Clear Instructions:** Ensure clear and effective communication within the team and with event officials.
- **Issue Reporting:** Have a clear protocol for reporting and escalating any issues or concerns.

### 4. Emergency Preparedness

- **Emergency Plans:** Have an emergency plan in place and ensure all team members are familiar with it.
- **First Aid:** Ensure the team has access to first aid equipment and that some members are trained in basic first aid.
